
Drug Testing

Stats

- » Safety--3.6X more in accident
- » Medical--3X more medical expenses
- » Productivity--1/3 as productive
- » Late--3X more likely to be late
- » Worker's comp--5X file claim
- » Absent--16X more likely to be absent
- » Suit--they lose job, you lose company

Stats

- » 75% of cocaine users take drugs on the job
- » 64% said it affects performance
- » 73% of drug users are employed
- » 15.5% employed in construction/contracting--the highest of any industry--8.1% in mfg)
- » 47% of Workers' Comp claims related to substance abuse



Cornell Study in Construction

» Cornell University

- > 51% ♥ in injury rate within 2 years of those who did drug testing compared to 14% decline in those that did not during the same time period
- > Fewer job site accidents and injuries
- > 11.41% reduction in workers' comp mod factor

Type of Testing

- » Hair
- » Urine
 - > lab-based
 - > instant
- » Oral
 - > lab-based
 - > instant



Type of Testing: Hair

- » Advantages—up to 90 days
- » Disadvantages
 - > Invasive especially if hair is limited--250 strands..shaved, crew, follicle challenged. Head, chest, arm, leg. Length—MUST be 1.5 "
 - > One week delay
 - > Expensive & specialized collection
 - > Hair care products/dyes can impact
 - > 2 week delay
 - > Dark vs. light
 - > Thick vs. thin
 - > \$\$\$\$
 - > Limited collection centers
- » Your greatest liability is on-the-job drugs not what they did on vacation 3 months ago



Type of Testing: Lab Urine GAO Undercover Study

| % | Failure |
|-----|---|
| 75% | DID NOT restrict adulterants or dilutants running water, soap, and air freshener WERE AVAILABLE |
| 67% | DID NOT secure all sources of water |
| 42% | DID NOT ask to empty pockets and display items |
| 19% | DID NOT check temperature |
| 17% | DID NOT use bluing agent in toilet |

Type of Testing: Lab Urine GAO

- » Adulterants, dilutants, substitutes widely available on Internet.
 - > Adulterants at 4 sites
 - > Substituted synthetic urine at 4 sites
- » Nothing was caught even when emptied pockets
 - > Strapped to leg, warmer
- » Nothing was detected at labs—synthetic urine, freeze dried urine, human urine

Type of Testing: Lab Urine GAO

- » EVERY drug masking product went undetected by the drug screening labs.
- » Companies that make drug-masking products are aware of government test standards
 - SAMHSA required to provide info to labs on how to test the validity of urine specimens, publicly providing detailed info on lab testing procedures on its Web site.



Type of Testing: All Urine Adulteration





- » Three Ways to Corrupt Urine Specimens:
 - > Masking agents
 - > Dilution
 - > Substitution

If you can't pass a urine test, you haven't "studied" for it!

Type of Testing: Lab Urine

- » Advantages of <u>lab-based</u> urine
 - > DOT approved—necessary for CDL license

Type of Testing: Instant Urine

- » Advantages: Instant
 - > NOTE: use instant then send to lab for confirmation--NOT DOT approved

Type of Testing: All Urine

- » Disadvantages
 - > 6-8 hours THC—no immediate detection
 - > Bathroom issues
 - > Handle urine—not dignified
 - > Storage space for instant tests
 - > Relatively easy to corrupt
 - > Hot climate—dilute, shy bladder, etc.
 - > Labs can't pick up everything
 - > Spills
 - > Summary—can look back longer but you're looking back at adulterated urine
 - > Google
 - + Type "Pass your drug test"—300,000 sites are listed—10 years ago there were 40

Type of Testing: All Urine Disadvantages

- » Long collection process
- » Additional costs
- » Time away from work (include fringe benefits)
- » Decreased productivity—random testing—time away from work

Type of Testing: Lab-based Saliva

- » Intercept® FDA cleared—assays and device
 - > #1 Brand recognition
 - > On market since 1999, 5M+
 - > All studies quoted on lab-based saliva = Intercept
 - > Never recalled
 - > FDA cleared for 9 panels +
 - + Amp, mAmp (including Ecstasy), Cocaine, Opiates, THC, Phencyclidine, Barbiturates, Benzodiazepines, Methadone
- » Oral-Eze
 - > Introduced late 2011
 - > Recalled three months after product introduction
 - > Back on market
 - > FDA cleared Amp, mAmp, Cocaine, THC, Phencyclidine, Opiates = 6
- » Quantisal
 - > Not FDA cleared for THC
 - > FDA cleared for Amp, mAMP, Cocaine, Opiates = 4



Type of Testing: All Urine

THC WOD (Window of Detection)

- » Detection time at 50ng/mL cutoff screens
 - > Up to 3 days for single event/occasional use
 - > Up to 10 days for heavy use
- » Detection time at 20ng/mL cutoff (DOT) screens
 - > Up to 7 days for single event/occasional use
 - > Up to 21 days for heavy use

Type of Testing: All Urine WOD

- » Drug dose/strength
- » Route of entry into the body
- » Duration and frequency of use
- » Rate of metabolism
- » Hydration level, food intake, physical activity
- » Testing sensitivity
- » Specificity of testing method



Type of Testing: Compare Window of Detection

| | Urine Easy to Adulterate | Intercept [®] Saliva Virtually impossible to adulterate |

| Marijuana | 3 days | Lab 0-24/36 hrs. |

Type of Testing: Lab-based Oral Intercept®5M Samples



Type of Testing: Instant Oral * Advantages—Instant * Disadvantages * Only 1 is FDA cleared * Forensic vs. workplace—short THC * No literature * Many state variations—confusing



Type of Testing: Lab-based Oral Intercept®

- » Intercept® FDA cleared—assays and device
- » 5 minutes per test
 - > Negatives 24 hr. Internet 24/7
 - > Positives 48 hrs. MRO
- » less \$ than lab-based urine
- » Virtually impossible to adulterate
- » Min. downtime
- » Max. productivity
- » Lowes, Publix, Kroegers, +++
- » +5 million
- » Don't touch saliva, don't have to spit




Type of Testing: Lab-based Oral Intercept®

- » THC
- » Cocaine
- » Opiates
- » Amphetamines, Methamphetamines
- » PCP
- » Ecstasy, Benzo, Barb, Hydrocodone, Hydromorphone, Oxycodone, Oxymorphone, 6MAM
- » Similar window of detection--oral/urine

Type of Testing: Lab-based Oral Intercept® Defensibility

- 1. Collection Site
- 2. Certified Laboratory—SAMHSA
 - > Screen and confirm
 - Cut-off levels for Intercept are lower than instant urine tests which means you will detect more positives
- 3. Medical Review Officer
- 4. Upheld in court 12 times

Under this system, testing is fair, accurate and defensible.

Type of Training: Intercept® Lab-based Oral

- » Complimentary training CD
- » Certification
- » No set up costs
- » Reps throughout country to assist all divisions

Type of Testing: State Comparison

- » Intercept® legal in 48 states with few regs (ME, HI)
- » Instant testing has many state regs.
- » Ex. In NC, can use Intercept[®] without restrictions but if you use instant drug test and a result is presumptive positive, you must perform confirmatory testing.

Type of Testing: Intercept® Case Studies

- » Georgia Pacific reduced costs by \$50,000 the first year.
- "When our urine positives decreased to 1%, we knew something was wrong. With Intercept, we are testing positive at the national average of approximately 5%" construction Company
- "We saw an increase in positive rates by using Intercept" (3%). You can study for a urine test but you can't do that for oral fluid!" Casino, Las Vegas, NV
- "We are picking up marijuana at same rate but will save more than \$100M on testing budget. We caught more Methamphetamine users and have decreased lost days from 1000/yr. to 50/yr." Manufacturing Co.

Summary: Drug Testing Presentation

- > Hair--costly, collection, 90 days
- > Lab-urine--easy to adulterate, GAO study, DOT
- > Instant urine--instant read, easy to adulterate
- > Lab-saliva--virtually impossible to adulterate, detects most positives
 - + Do you want the product that detects the most positives or do you want the product with the longest window of detection?
- > Instant saliva—instant read, miss 80% of THC
